THE ANNA'S HOUSE FOUNDATION IS IN THE PROCESS OF ESTABLISHING SUPPORT GROUP MEETINGS, ALLOWING FAMILIES TO COME TOGETHER AND LIFT EACH OTHER UP IN PRAYER AND EMOTIONAL SUPPORT.
